

Indonesian Subsidiary's New Factory Complete

Tokai Rubber Industries, Ltd. (Head Office: Komaki City, Aichi Prefecture, President: Yoshiaki Nishimura) informs that at its Indonesian motorcycle and car hose manufacturing and sales subsidiary PT. Tokai Rubber Auto Hose Indonesia (abbreviation: TRHI), a new factory has been completed, and opening ceremony held.

TRI group set up TRHI in August 2011 in order to support the expansion and increasing production activity of Japanese and European car makers in Indonesia, where amidst underlying economic growth, the demand for motorcycles has grown paving the way for that of 4-wheeled vehicles. Whilst starting work on the new factory soon after the company's establishment, in order to begin delivery of product as quickly as possible, TRHI did begin the mass production of motorcycle resin hose at a leased factory in 2012 as an interim measure until the new factory was completed. The new factory, along with the relocated production equipment from the previously leased factory, will also be fitted with new production lines, and will be a production base for 4-wheeled vehicles' resin and rubber hoses in addition to motorcycle resin hose.

Those present at the opening ceremony included the local Industrial Park associates and people from the motorcycle and automobile makers' subsidiaries etc., and they all celebrated the completion of the new factory. Group President Mr. Nishimura greeted the attendees with an emphasis on his intention to strengthen the business foundation in growth markets even further, saying "In Indonesia where we expect market growth for both motorcycles and 4-wheelers - it is very pleasing to be able to send out locally made products to our customers. We will continue to contribute to the growth and prosperity of the motorcycle and car industries and the local community".
