

## **Establishment of New Automotive Hoses Manufacturer in Poland**

- Establishing a key strategic manufacturer for Automotive Hose Business in the EU -

Sumitomo Riko Company Limited (Head Office: Nakamura-ku, Nagoya, President and COO: Tetsu Matsui) has established a new Automotive hose manufacturer and selling company named SumiRiko Automotive Hose Poland Sp. z o. o. (abbreviated as SRK-HP) in Sosnowiec, Poland that will begin operation in the fall of 2016. Our Group has already established two different automotive anti-vibration rubber manufacturing bases and selling companies operating in Poland named TRI (Poland) Sp. z o.o (abbreviated as TRP) and SRK-HP will be the third bases.

The Sumitomo Riko Group is currently operating at 103 locations in 23 countries around the world. In the automotive parts business, we have established R&D and supply chain in the five major regions of the world (Japan, the Americas, Europe, Africa, China/South Korea and Asia) to provide automotive manufacturers with high quality products globally.

In January of this year, our automotive hose business established a system to quickly meet the needs of customers in each region and increase profitability by opening "regional centers" in North and Central America, South America, Europe and Asia. One of these centers is a subsidiary acquired in 2013 called Dytech-Dynamic Fluid Technologies S.p.A. (Main office located in Italy, abbreviated as Dytech) which is actively expanding its business with major automotive manufacturers in Europe. The newly established SRK-HP aims to increase our business with Japanese automotive manufacturers in Europe. While Dytech is aiming to increase its business with European automotive manufacturers. The company will play a key strategic role and work to further expand our automotive hose business in Europe with Dytech.

The Sumitomo Riko Group will continue to strive for accelerating growth become a "Global Excellent Manufacturing Company" by utilizing the sales channels of Anvis Group GmbH (Main office located in Germany, abbreviated as Anvis), a German manufacturer of automotive anti-vibration rubber acquired in 2013, while working closely with Dytech having an advantage in modularization technologies.
